2. The Manyoni District Council now invites sealed Tenders from eligible "National" providers of Cadastral Survey of different areas Mwembeni, Muhalala, Mwanzi, Majengo, Msagati, Tambukareli, Mitoo, Kipondoda and Kaloleni at Manyoni District Council.
3. Tendering will be conducted through the National Competitive procedures specified in the Public Procurement (Regulations, 2013 - Government Notice No. 446 and is open to all Tenderers as defined in the Regulations.
4. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary of Tender Board Manyoni District Council from 07:30 to 15:30 on Mondays to Fridays inclusive except on public holidays.
5. A complete set of Tendering Documents in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of Tsh.100,000. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to Manyoni District Council Treasure Office.

6. All Tenders must be accompanied by a Tender Securing Declaration in the format provided in the Tendering Documents.

All Tenders in one original plus two copies properly filled in, and enclosed in plain envelopes must be delivered to the address *Secretary of Tender Board, Manyoni District Council, P.O.Box 60, Manyoni.* at or before 10:00 Date 21.11.2018 Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the Manyoni District council Social Hall
8. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, and not opened and not read out in public at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
